#### **SECTION 2 – MANDATORY REQUIREMENTS**

#### 2.6 BINDING OF ANNUAL ROLLS

The annual rolls vary in thickness and some may be very large. Each municipality is to receive two copies of their annual roll. A few municipalities will require more than two copies. Binding must be sturdy enough so that it doesn't separate after repeated use. If any separation does occur, the service provider is required to immediately replace it at its own expense.

**Appendix E** illustrates a sample Annual Assessment Roll. The size of the roll will vary for each municipality. **Appendix F** provides the number of properties per municipality. Each page of a roll can accommodate up to seven properties. This information is provided to assist bidders with calculating the size of each roll.

Further information is outlined in the Request for Proposals document.
